#### <u>URBAN AGRICULTURE: Did you know you can qualify as a farm?</u>

The current Biden administration has been taking strides to expand urban conservation and urban agriculture initiatives. One such way is to allow for urban farming to be more incentivized. To do this, the USDA (United States Department of Agriculture) and the FSA (Farm Service Agency) have been making moves to make it easier for people living in the city to qualify to become a farm. You might be asking, how would I be able to do this, and why might I want to do this? Simply put, anyone in our neighborhood looking to be an urban farmer would qualify, and if you consider it and register as a farm (registration is free), you can then apply for grants, subsidies, and incentives offered through the USDA. For instance last year the USDA released the high tunnel initiative, which typically focused on rural landscapes, but expanded into the urban environment. They fund 70-90% of the cost of a high tunnel/greenhouse for urban farmers (as long as you qualify with certain rules, e.g. you must plant your stock in the ground). This is just one of many opportunities. So if you have an interest in growing your vegetables and fruits, raising some chickens, having a beehive, or growing show flowers, you might want to think about qualifying to become an urban farm, and opening up avenues you might not have considered.

If you are interested in learning more about this, we will be having two guest speakers at our next Neighborhood Association meeting on July 7<sup>th</sup> at 7 p.m. at Hunter Presbyterian Church. They will be discussing Agriculture and Urban Conservation and the grants and opportunities that are now available to people living within a city, that have previously only been available to rural applicants. Keep in mind that Kentucky is still figuring out what this means for our local urban environments, but our two speakers are at the forefront of those discussion. So, if you would like to find out more, or offer insight into what you would like to see with urban conservation/agriculture with the USDA please attend.
